

Dear Friends in Christ.

This year, Easter will be celebrated on April 21st. We will remember the Resurrection by singing praise to God with joyful shouts of Hallelujah, wearing bright colored clothing, enjoying the abundance of flowers, seeing cute images of bunny rabbits, and eating delicious chocolate eggs.

But wait a minute, we are not there yet, we are just beginning the month of March. To get the full picture and meaning of the Easter Resurrection, we need to first journey through Lent, which begins on Ash Wednesday, March 6th this year.

The traditions of Ash Wednesday and Lent help us remember that before there is any resurrection, there must first be a death. Before a beautiful daffodil flower rises from underneath the ground, it must first be buried down in the dirt. Or in the words found in a gospel text attributed to Jesus, "unless a grain of wheat falls into the earth and dies, it remains just a single grain; but if it dies, it bears much fruit" (John 12:24).

We know that our mortal bodies come from the same chemical elements found in the dirt on earth---oxygen, carbon, nitrogen, etc. Or in the words found in an ancient text of the Bible, "God formed humans from the dust of the ground" (Genesis 2:7).

So, on Ash Wednesday, when I take my fingers to trace a cross on someone's forehead with ashes, I offer a traditional blessing by saying, "Remember that you are dust, and to dust you shall return."

The prayer for Ash Wednesday sounds humbling. Indeed, it is. As it should be. The savage, tortuous crucifixion of Jesus was humbling, to put it mildly. Even the Son of God could not escape the death that awaits us

Isn't the 40 days of Lent, therefore, an important period of time outside of the other 325 days in the year to reflect humbly on the mortality of life?

This time of reflection may prepare us to see more clearly with faith and hope what's on the horizon. As we journey through the 40 days of Lent, we don't lose sight of the resurrection, much like when the sun goes down at dusk and we go to sleep, we look forward to waking up to the sunrise of a new

Like every new day, new life is always arising. I was beautifully and intimately reminded of this recently when I held in my arms a newborn baby who was only 5 days old.

I would like to conclude by suggesting that we experience our 40 days of Lent like a caterpillar that spends several days in a cocoon being changed, transformed, to soon emerge as a new butterfly, a vivid reminder of the Easter Resurrection that awaits us all.

#### PLEASE READ THE NOTES TO FULLY UNDERSTAND THE NUMBERS ABOVE!

- 1. General Fund is the operating funds to run the Church. The General Fund Income consists of General Contributions, Income that has been designated for building use, and contributions to the Endowment Fund. Expenses include Pastoral and Support Staff salaries; administrative costs for supplies; utilities, building and grounds maintenance; and church committees expenditures. The Difference shown in the General Fund is due to the transfer of money from the General Fund to the Strategic Planning Projects that were approved in the 2019 budget. The funds utilized to cover the transfer came from assets that have accumulated over the past few years. The negative number only reflects the transfer itself. The Church is not in a negative cash flow position.
- 2. <u>Missions Fund</u> income is from designated contributions from Church members, the sale of Food City Cash Cards, Kroger charity program contributions, and Dimes for Missions. Expenses are disbursements to charities and bank charges for counting coins. The transfer amount is the money moved from the General Fund to Missions as part of the budgeted Church support to Missions.
- 3. <u>Property Improvement Fund (PIF)</u> income is from designated donations from church members. PIF expenses are any property and facility expenses not covered by day-to-day maintenance activity.
- 4. <u>Pass-Thru Fund</u> is to account for money that comes through the Church but is not used to cover Church expenses. It is primarily for items such as special disaster collections, NIN/Peacekeeping, One Great Hour of Sharing, Christmas Joy, Men's Fellowship, Women's Fellowship, etc.
- 5. <u>Strategic Planning Projects.</u> The Church Sanctuary Carpet and Chancel Upgrade project is complete. The second payment per the agreed to contract has been made. The Church withheld \$5,000.00 as final payment while some minor installation issues are addressed. Final payment will be made in February.
- 6. <u>Transfer</u> is the term used to move money from one fund to another fund. Transfers are generally from the General Fund to the Missions Fund, the Property Improvement Fund, and Strategic Planning Projects. For instance, money is transferred from the General Fund to the Missions Fund on a quarterly basis to meet the congregation approved budget for Missions.
- 7.  $\underline{\mathbf{Difference}} = \text{Income} \text{Expense} + \text{Transfers}$

A complete picture of all the assets of the Church (Balance Sheet), 2019 Income and Expenses, and 2019 Budget Status are posted on the Church Events Bulletin Board in the Fellowship Hall.

# Fairfield Glade Community Church Board Minutes - February 14, 2019 Pending Approval

1. **Opening Prayer:** Having declared a quorum, Jim Hansen called the meeting to order. Dennis Flynn offered an opening prayer.

- 2. Agenda review and revisions: None
- 3. **Approval of January Minutes**: Item o. under Committee Reports was amended to reflect that Worship and Music met on Monday, January 7<sup>th</sup>. Fred Wong moved to approve minutes as amended. Al Joseph seconded the motion and the motion passed.
- 4. **Treasurer's report:** Michael Nowacki: Michael amended the "Church Finances" report to be more informative and clearer. #5 addresses Strategic Planning projects. We're in a positive cash flow position. The report has been placed of file for audit.
- 5. **Membership Report:** Jim Hansen: Jim reported that as February 11<sup>th</sup>, we have 253 members and that we have received 96 pledges totaling \$197,500.00 towards the 2019 Budget.
- 6. Pastor's Report: None

#### 7. Old Business:

- a. Jim will email a draft of the ERT's (Emergency Response Team) ERP (Emergency Response Plan) to the Board members to review and approve the basic concept of this plan to allow the ERT to proceed.
- b. Final report on the Re-carpeting/Reupholstering Project, Stained Glass Project, and Narthex Furniture Project. The Re-carpeting/Re-upholstering project has now been completed, Tim Hammond came back to finish some punch list items and the final payment has been made. Both the Narthex Furniture Project and Stained Glass Windows Project have been completed as well.
- c. Review and act on request from Jerry Allard for Board members to serve Communion. Jerry Allard has requested the Board serve Communion both March and September. Jim will communicate the list of Board Members that will be serving this March to both Jerry Allard and Pat/Laurie.
- d. Discuss Columbarium Trust Letter versus S.O.P. and update Board on Columbarium Trust sign project. Jim updated the Board, as the Columbarium is not a "committee" under the Board but a stand-alone entity, do not have an SOP. For the benefit of future members, there will be a Columbarium Trust Letter in Committee section of Board manual that more clearly defines this relationship. Jim will have the Office place a copy of this letter in the Members mail boxes to be placed in their respective Blue Books.
- e. For the records, since the last Board meeting, Jim Hansen polled Board members via email for the following: whether anyone had issues if the contractor did not put up the complete privacy rail in front of the choir loft. The contractor is proposing a modified railing that would only extend from the left staircase to approximately the middle of the piano and the other side would only extend from the right staircase to approximately the middle of the organ. These rails would be installed permanently (not removable for concerts). And the contractor would modify his contract to reflect this change. Jim received 9 responses and all stated they didn't care one way or the other. The change to this railing has been completed.

#### 8. New Business

- a. Review and act on Facilities Use Permit from Dana Beal on behalf of the Plateau Women's Chorus for a onetime rehearsal on Saturday, February 23<sup>rd</sup> from 10 AM to 1 PM. Nancy Nowacki moved to approve the Facilities Use Permit from Dana Beal for Saturday, February 23<sup>rd</sup>. Fred Wong seconded the motion and motion was approved.
- b. Review and act on Facilities Use Permit from Dana Beal on behalf of the Plateau Women's Chorus for a onetime rehearsal on Saturday, April 13<sup>th</sup> from 1 PM 3 PM. Al Joseph moved to approve the Facilities Use Permit from Dana Beal for Saturday, April 13<sup>th</sup> in preparation for their concert here on Sunday, April 14th. They will need the Sanctuary and a Sound Engineer for this rehearsal. Judy Moore seconded the motion and the motion was approved.
- c. Susan Milledge moved to allow the sale of books by DJ Garrison at the Fellowship Dinner. John Zanichelli seconded the motion and the motion was approved
- d. Marty Smith moved to accept the request from Missions to send out a letter for One Great Hour of Sharing. Roy Koskinen seconded the motion and the motion was approved.
- e. Review and act on request from Personnel Committee to add another member at large to their committee. Fred moved to accept the request from Personnel Committee to add Patty Smith as at-large member for 3 a year term. Al Joseph seconded the motion and the motion was approved.
- f. Review and act on request from Strategic Planning to replace a member at large to their committee. Strategic Planning wants to add Norm Brinsley to replace Jim Buxton. Dennis moved to accept the request. Al Joseph seconded the motion and the motion carried.
- g. The Board was advised that the Personnel Committee would no longer be responsible for the Bi-Annual Time & Talent Survey. Effective immediately, this survey has been transferred to the Stewardship sub-committee under the Finance Committee. Both Personnel and Finance Committee's will update their respective S.O.P.'s to reflect this change. The next survey will come out in 2020.
- h. Review and act on list of members requesting access to new Lock Box Code for 2019. Al Joseph moved to approve the access code list as submitted by the Office Manager. Fred Wong seconded the motion and the motion carried.
- i. Review and act on recommendations from Property and Facilities to place order for new chairs for Fellowship Hall. Susan got 2 bids for chairs for Fellowship Hall. Next week Property and Facilities will do an inventory of what we have and what can be donated to Habitat for Humanity. Some samples have arrived, more to come. The bid is \$5548.00 for 200 chairs plus \$50 for delivery. We have \$6000.00 budgeted. The Board members want to have an opportunity to look at chair/samples. Deferred action till March/April Board meeting.
- 9. Board members were reminded of important dates for the month of February.

#### 10. Committee Reports

- a. Christian Response: Judy Moore: We didn't meet in February. 6 E-Prayer requests and 33 visits to Good Sam's in January.
- b. Columbarium Trust: John Schaefer: We met on January 12. The audit was successful. A stone sign for the entrance to the Columbarium is being worked on. We are also considering a small sign in front of the church directing visitors to the Columbarium.
- c. Community Enrichment: John Zanichelli: All concerts planned for whole year and we are working on 2020.
- d. Finance: Jim Hansen: Phone and internet alternatives are being discussed, but for 2019, we will commit to a 2-year contract with Frontier. All audits from 2018 have been completed. This should realize an approximate \$30 per month savings versus not having a contract.
- e. Memorial: Dennis Flynn: We will meeting on Jan 24<sup>th</sup>;
- f. Missions: Ed Freels/Jim Hansen; There is a letter going out from Missions
- g. Nominating: Al Joseph: We held our 1<sup>st</sup> meeting and went over S.O.P. Next meeting probably won't be until June when we will become more active.

- h. Parish Life: Marty Smith: There are no issues needing Board approval.
- i. Pastor Parish Relations: Roy Koskinen: We met on 21<sup>st.</sup> Who is working with office staff on pulpit supply? Gene will be minister this Sunday while Pastor James is on vacation.
- j. Personnel: Ed Freels/Jim Hansen: no update
- k. Property and Facilities: John Schaefer: We had a meeting this morning. We are changing lighting. We are evaluating tinting sanctuary windows. There are water issues at Fireside door. The Board suggested that we not allow the taping of signs for events, etc. on church doors.
- 1. Strategic Planning: Fred Wong: The Community Relations sub-committee has been renamed Marketing Sub-committee. Fred moved to approve the publication of the Stained Glass Window pamphlet. Roy Koskinen seconded the motion and the motion carried. The Marketing Committee is updating its SOP and will be updating projects and plans to congregation. The Committee Fair will be April 28<sup>th</sup>. Susan suggested putting new brochure in paper as interest article.
- m. Technology & Communications: Nancy Nowacki: We met this morning. We are looking at new technologies. We want to update photo directory every year. TV will be up and running for Committee Fair.
- n. Visitor Member Outreach: Susan Milledge: We met on Feb. 12<sup>th</sup>. We are reviewing our SOP. We want to have a booth at the Flag Day festival. We will be adding 4 members on February 24<sup>th</sup>. Road pick up is scheduled for this spring.
- o. Worship & Music: Roy Koskinen: We met Feb. 5<sup>th</sup>. Communion will be on Pentecost Sunday in June, which is 2<sup>nd</sup> Sunday. Angela has requested a leave of absence for June 16<sup>th</sup> July 4<sup>th</sup>. There will be no Ash Wednesday service.
- p. Report from UCC/Presbytery Delegates: Nancy Nowacki. UCC conference will be at Pleasant Hill. John McArthur is our delegate for the Presbytery. The Presbytery budget passed for 2019.
- 11. Dennis Flynn presented the guidelines for Drivers for members. Linda Cronwell discussed what Christian Response is responsible for according to the SPC guidelines.
- 12. Dennis Flynn offered a closing prayer.
- 13. John Zanichelli moved to adjourn the meeting. Fred Wong seconded the motion and the motion passed. The meeting was adjourned at 4:04 PM
