OF

FAIRFIELD GLADE COMMUNITY CHURCH

The undersigned natural person or persons, having capacity to contract and acting as the incorporator or incorporators of a corporation under the Tennessee General Corporation Act, adopt the following charter for such corporation.

- 1. The name of the corporation is Fairfield Glade Community Church.
- 2. The duration of the corporation is perpetual.
- 3. The address of the principal office of the corporation in the State of Tennessee shall be P. O. Box 1665, Fairfield Glade, Tennessee 38555, County of Cumberland.
- 4. The corporation is not for profit.
- 5. The purpose or purposes for which the corporation is organized are:
 - A. The establishment of the Fairfield Glade Community Church as a religious corporation, with the following objectives:
 - It shall be the purpose of the Fairfield Glade Community Church to bring together all Christians who seek a common meeting point in their Christian Faith, and a simple basis on which to rest their Christian fellowship, with full freedom for spiritual thought and liberty of personal conviction.
 - II. The Fairfield Glade Community Church shall remain interdenominational in fellowship, and shall accept into its membership all those who accept Jesus Christ as their Savior and Lord, and the Bible as the rule of conduct and discipline, and who indicate that they will make this their place of worship and work for the Lord and his Kingdom, in full sympathy with the Church and its program.
 - III. The further objects of this religious corporation shall be the support of p public worship, instruction in the Bible, religious instruction thru church schools, etc., and charitable and missionary projects of every kind and nature.
 - IV. For the accomplishment of its purposes, the corporation herein created shall have and possess any and all rights, powers and privileges necessary or proper for the attainment and fulfillment of its aims.
- 6. This corporation is to have members.
- 7. Other provisions:
 - I. The rules of membership in the Church shall be as provided and authorized in the By-Laws.
 - II. The Official Board of the Fairfield Glade Community Church shall manage all secular activities and oversee all religious endeavors of the Church according to the By-Laws. The permanent officers of the Board shall consist of a President, Vice-President, Treasurer and Secretary, and any other officers which later may be deemed necessary. The Secretary can be an elected or appointed position.
 - III. The Official Board of the Fairfield Glade Community Church shall not be fewer than seven (7) nor more than fifteen (15) in membership, the exact number to be specified in the By-Laws. They shall be elected from the membership of the Church in such manner and for such terms as may be provided in the By-Laws of this Corporation, or until their respective successors have been elected and

qualified. The Board shall have the authority to prescribe the manner of electing members to fill vacancies that may arise in such Board when either by death or resignation the said membership of the Board shall become vacant before the expiration of the term of which the said member was elected, unless provision is otherwise made by the By-Laws of this organization for the filing of such vacancy by action of the membership.

- IV. All of the property of the religious corporation herein created shall be managed and controlled by the Official Board of the Fairfield Glade Community Church.
- V. The said incorporators shall form the Interim Committee with a coordinator, secretary, and treasurer elected from the Interim Committee by members of the said committee. The Interim Committee shall serve until members of the Official Board can be elected by the Church membership according to the By-Laws.
- VI. The members, may at any time, voluntarily dissolve the Corporation by a conveyance of its assets and property to any other corporation, or corporations, holding a charter, from the State for the purposes and objectives heretofore described for this Corporation, after first providing for corporate debts.
